## 5. Fire-fighting measures

### 7. Handling and storage

#### Handling

##### Advice on safe handling

Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentration higher than the occupational exposure limits.

The product should only be used in areas from which all naked lights and other sources of ignition have been excluded.

Preparation may charge electrostatically: always use earthing leads when transferring from one container to another.

Take measures to prevent the build up of electrostatic charge.

Wear shoes with conductive soles.
