## SECTION 4: First aid measures

### 4.1. Description of first aid measures

#### General information

## 7.1. Precautions for safe handling

### Advices on safe handling

Avoid contact with skin, eyes and clothes. Avoid respiration of swarf. When using do not eat, drink or smoke. Personal protection equipment: refer to section 8. ### Requirements for storage rooms and vessels
